SCHEME OF DELEGATION

(REVISED EDITION 8.2013)

This scheme of Delegation has been approved by the Governing Body at its meeting on *21 January 2013*. The Scheme has been developed to clarify the responsibilities and powers of Governors and members of Staff employed at the School in respect of key aspects of the management of the School and to ensure compliance with legal requirements and, where appropriate, Local Education Authority policies.

The delegations set out in the Scheme are delegated to the specified committees of the Governing Body and post holders employed at the School and not to named individuals. Delegations cannot be exercised other than by the designated post holder or committee, unless otherwise directed or agreed by the Governing Body.

In the absence or incapacity of the Head Teacher, the delegations stand delegated to the Deputy Head Teacher unless otherwise directed or agreed by the Governing Body. In the absence or incapacity of a post holder other than the Head Teacher, the delegations stand delegated to the Head Teacher unless otherwise directed or agreed by the Governing Body. Instead of exercising delegated powers, a post holder or committee may refer the matter to the appropriate committee or the full Governing Body.

The Scheme will be reviewed on a regular basis and is made without prejudice to the powers and duties of the Governing Body and its committees.

The Scheme of Delegation uses the following KEY when allocating authority to decision makers.

Level 1 = Decisions made by the Governing Body

Level 2 = Decisions made by the Governing Body with advice from the Head Teacher

Level 3 = Decisions delegated to the Head Teacher Level 4 = Decisions made by the Head Teacher

Blocked Off (X) = Function cannot legally be carried out at this level

Tick (V) = Recommended level(s) or where the law assigns specific responsibility

Blank = Action could be carried out at this level if the Governing Body so decide, but is

not recommended

Asterisk = Functions which the whole Governing Body must consider
