Birthday treats

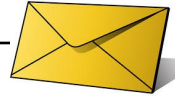
It is lovely to see parents bringing in treats for the children to hand out on their birthdays.

Did you knowThe Government gives extra money to schools called 'The Pupil Premium Grant' to support children who:

- Are entitled to free school meals - or have been at any point in the last six years
- Looked after children
- Service family children

For every child registered, RLK gets £1320 this year to support their learning, emotional development and access to a range of first-hand experiences.

Some of this money is used to support quality first teaching and interventions within the school. If you are registered, you could also get *help with costs of school trips or clubs*.

Please register to make sure your child doesn't miss out and has full access to this support.

How does it work?

- First, check if you qualify—it is not just if you are unemployed, so please look at the list below.
- Registering is really quick and easy—if you think you qualify but would like assistance please contact the school office who will be happy to help you to register.

No one will know you have registered and it will not affect any other benefits you are claiming.

Do you qualify?

You can register your child for Free School Meals if you get any of these benefits:

- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under Part VI of the Immigration and Asylum Act 1999
- The Guarantee element of State Pension Credit
- Child Tax Credit, provided they are not entitled to Working Tax Credit and have an annual income (as assessed by HM Revenue & Customs) that does not exceed £16,190
- Working Tax Credit 'run-on' - the payment someone may receive for a further four weeks after they stop qualifying for Working Tax Credit
