E-scooters & electric bikes - do you know the law?



E-scooters are classed as motor vehicles under the Road Traffic Act 1988.

You therefore need to have:

- **A driving licence**
- **Insurance**
- **MOT and Tax**

It is against the law to ride them on the roads/ pavements or in public spaces. This includes car parks and play parks.

Legal **electrically assisted pedal cycles** can be ridden by people over 14 years old. To be compliant with the law:

- It must have pedals which you need to turn to propel it
- It should have a motor of 250 watts or less
- The electrical assist should cut out at 15.5 mph

If it doesn't meet these criteria, it is classed as a motor vehicle and needs a licence, insurance, MOT and tax to be ridden legally.

If you use an e-scooter or e-bike against the law, you run the risk of it being seized and destroyed. You may also be prosecuted.

Child Sexual Exploitation (CSE)

What is child sexual exploitation?

Child sexual exploitation (CSE) is a type of sexual abuse. When a child or young person is exploited they're given things, like gifts, drugs, money, status and affection, in exchange for performing sexual activities. Children and young people are often tricked into believing they're in a loving and consensual relationship. This is called grooming. They may trust their abuser and not understand that they're being abused.

Children and young people can be trafficked into or within the UK to be sexually exploited. They're moved around the country and abused by being forced to take part in sexual activities, often with more than one person. Young people in gangs can also be sexually exploited. Sometimes abusers use violence and intimidation to frighten or force a child or young person, making them feel as if they've no choice. They may lend them large sums of money they know can't be repaid or use financial abuse to control them. Anybody can be a perpetrator of CSE, no matter their age, gender or race. The relationship could be framed as friendship, someone to look up to or romantic. Children and young people who are exploited may also be used to 'find' or coerce others to join groups.

Types of child sexual exploitation (CSE)

CSE can happen in person or online. An abuser will gain a child's trust or control them through violence or blackmail before moving onto sexually abusing them. This can happen in a short period of time. When a child is sexually exploited online they might be persuaded or forced to:

- send or post sexually explicit images of themselves
- film or stream sexual activities
- have sexual conversations.

Once an abuser has images, video or copies of conversations, they might use threats and blackmail to force a young person to take part in other sexual activity. They may also share the images and videos with others or circulate them online.

Gangs use sexual exploitation:

- to exert power and control
- for initiation
- to use sexual violence as a weapon.

What to do?

It's important to spot the signs and act quickly if you think a child is being groomed or is becoming involved with a gang.

Talk to them and listen (It's crucial that they feel they're able to talk to you, or another trusted adult outside of the gang)

Be Aware (Try to be aware where they are when they're out, who they're with and what they're doing on social media)


